
To reduce crashes, injuries and deaths due to traffic crashes on the Flathead Reservation.

















Frequency of Motor Vehicle Crashes, by Top 10 Most Harmful Events (2004-2013)



Existing Safety Programs

- SOAR
- DUI checks/stops
- Applied for engineering funding ADA
- Safety Audit (by MDT)
- Road Safety Audit
- Emergency Communications Program (Dixon area currently out)
- Safety Projects at Various Locations by MDT

Safety Issues Identified

- Distractions/Mobile device use (Texting) while driving
- Bridge Rails, Guardrails and approach rails
- Intersections (blind, lighting, advance warnings)
- Lighting (maintenance, bullet proof covers)
- Road Surface Conditions (rough surface causing accidents)
- Lack of or Inconsistent data collection systems
- Speed on US 93
- Pedestrian Facilities
- Snow removal large events and lack of capable equipment
- Handicap ramps mobility and access

Strategies Identified

- Complete Road Safety Audits MDT and CSKT
- Continue Transportation Safety Committee, annual meetings
- Investigate/pursue CTS funding for adjoining counties and towns
- Timberlane Road to Ronan separated pedestrian path
- Apply to TAP program for ADA improvements
- Develop a centralized dispatch center
- Hire traffic safety officers for enforcement
- Continue guardrail and bridge rail upgrade programs
- Support Primary Seat Belt Law
- Review school bus stop locations for upgrades or consolidation

Strategies Identified

- Install message boards warning motorists during high volume periods
- Expand Safety Education to include:
 - Billboards
 - Tune your radio informational signs
 - Social media
- Install advance warning signs for signals
- Install EMS repeater
- Better Track wildlife crashes
- Develop list of railroad crossing locations and review for upgrades
- Gravel Roadway maintenance research gradations that hold up better
- Develop additional separated pathways in St. Ignatius, Ronan, and Pablo

- Seat belt surveys
- Crash data monitoring
