AUTODESK CIVIL 3D 2026:



ESS CADD is in the early stages of research for the upgrade to Civil 3D 2026. The tentative plan for the upgrade is to be launched in late spring of 2026.

MDT CIVIL 3D STATE KIT UPDATE:

BIM 360 TRANSITION TO ACC Docs:



MDT has started the transition from BIM 360 to Autodesk Construction Cloud (ACC) Docs with 4 pilot projects. Once testing is complete on the pilot projects, scheduling will start for moving all MDT projects from BIM 360 to ACC Docs. The planned timeline is to be completed by Fall of 2025. This transition will not affect file structure and will improve file function within Autodesk software.

SUBMITTING THE RIGHT TICKET:

Reminder that there are two different ways to submit tickets to ESS CADD via either submitting a case or submitting a service request.

-Service Request: is an inquiry from MDT users to request service such as adding or enhancing a tool within Autodesk or needing to be added to a project in BIM360/ACC. Only MDT users have the capability to submit a Service Request.

- A Case: is an inquiry to fix something that is broken and not working. A case is to be opened when your computer and/or software are not functioning properly.

ESS CADD has different ways of interacting with both a Service Request and a Case within our ServiceNow platform so it is crucial that you submit the correct ticket.
