Staff recommends awarding projects 101,102, 104,105,106,107,108,109,110,111,112 and 113 to the responsive low bidders. Project 103, East Holly Street Sidney is outside of guidelines for award and will be re-advertised. ER Projects 114 and 115 were awarded July 13, 2018.

Commissioner Lambert moved to approve the staff recommendation to award projects as recommended by staff to responsive low bidders and reject project 103. Commissioner Jergeson seconded the motion, all Commissioners voted aye.
