## 2. Design Build – Kalispell ADA Upgrades

Based on the above scoring information, the Selection Committee recommends the following:

- 1. Recommend the two unsuccessful responsive Firms receive the stipend payment of \$30,000.
- Award the contract to the KNIFE RIVER/WGM/BIG SKY PR Design-Build Team, with the highest Total Points, considered the Best Value for MDT, in the amount of \$2,580,000.00.

Commissioner Fisher moved to award the Kalispell ADA Upgrades – Design Build Project to the Knife River/WGM/Big Sky PR team with the highest total points and considered the best value for MDT and award the \$30,000 stipend to the unsuccessful firm. Commissioner Fisher noted that the MCA, Montana Codes Annotated 18-2-205(2) and 18-2-205(3) noted in the staff recommendation were not correct and should read 60-2-111 & 60-2-137, Commissioner Sansaver seconded the motion, all Commissioners voted aye.
