Five (5) projects were advertised and a total of eleven (11) bids were received. Staff recommends awarding projects 101, 102, 103, and 105 to the responsive low bidders. Project 104, Path Preservation – Kalispell is outside of guidelines for award. Staff recommends rejecting and repackaging at a later date.

Commissioner Sanders moved to approve the award of projects 101 thru 105 to the responsive low bidders, Commissioner Aspenlieder seconded the motion, all Commissioners voted aye.

 2. Construction Project on State Highway System Montana Crossroads Subdivision – Three Forks

Under MCA 60-2-110 "Setting priorities and selecting projects," the commission shall establish priorities and select and designate segments for construction and reconstruction on the national highway system, the primary highway system, the secondary highway system, the urban highway system, and state highways. This statute exists to ensure the safety of our system, protect transportation investments, and encourage coordination on public and private infrastructure improvement projects that impact MDT routes.

Montana Crossroads Subdivision - Three Forks

Montana Crossroads, LLC is proposing modifications to US-287 (N-8) to address traffic generated by their new development near Three Forks. Proposed improvements include the construction of new approaches and the installation of northbound right-turn lanes on US-287.

MDT headquarters and Butte District staff have reviewed and concur with the recommended improvements. Montana Crossroads, LLC will provide 100 percent of project funding and will be required to complete MDT's design review and approval process (to ensure that all work complies with MDT design standards).

When complete, MDT will assume all maintenance and operational responsibilities associated with the proposed improvements.

Summary

Montana Crossroads, LLC is proposing modifications to US-287 (N-8) to address traffic generated by their new development near Three Forks. Proposed improvements include the construction of new approaches and the installation of northbound right-turn lanes on US-287.

Staff recommendations

Staff recommends that the Commission approve these modifications to US-287 - pending concurrence of MDT's Chief Engineer.

Commissioner Aspenlieder moved to award the Construction Project on State Highway System, Montana Crossroads Subdivision – Three Forks, Commissioner Sanders seconded the motion, all Commissioners voted aye.
