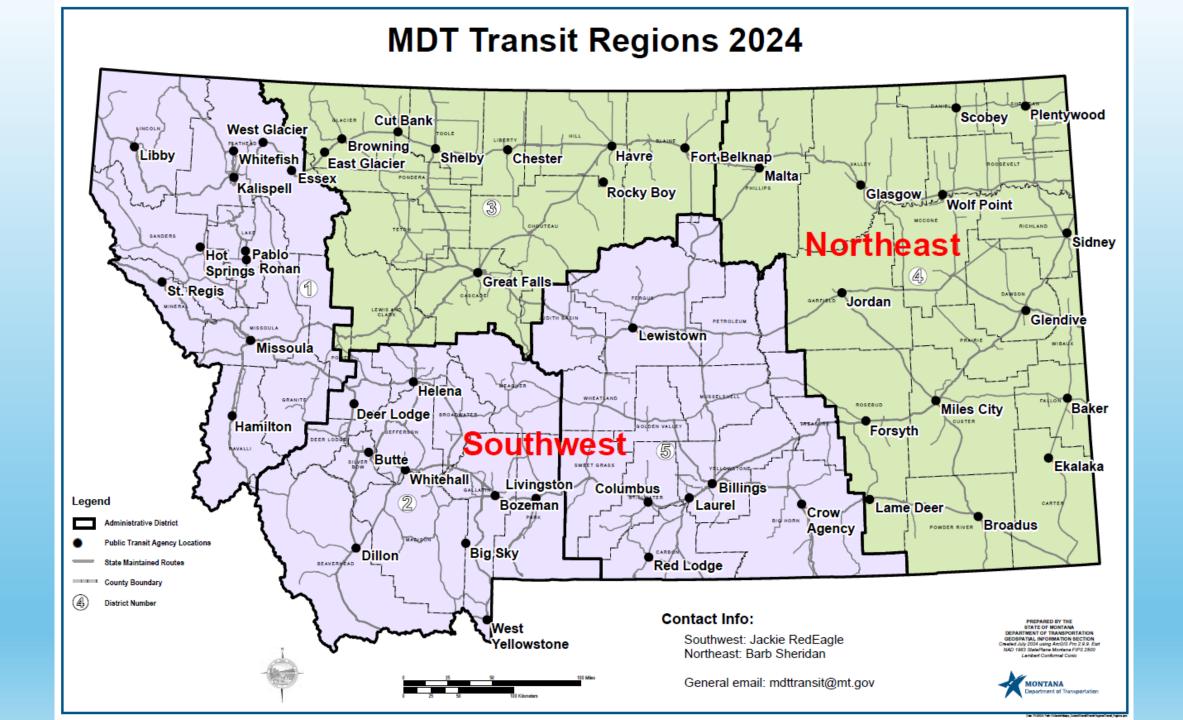

#### NATIONAL TRANSIT DATABASE (NTD) SFY 2024

- BlackCat NTD reporting module is operational for SFY 2024
- Mode MB FIXED ROUTES GTFS deadline is October 14, 2024
- NTD SFY 2024 report year will open soon Please check your data in BlackCat for errors, such as a missed payment that wasn't reported in BlackCat but is in NTD, etc.,
- Subrecipient first validation submittal is due October 14, 2024

# TRIANNUAL COMPLIANCE REVIEW COMMON MISTAKES

- Internal controls separation of duties
- No policy or SOP for fare collection from start to finish
- No training records for management and/or employee's
- Pre and Post trips vehicle, mileage, date, and signature
- Preventative maintenance logs and maintenance supporting documents (invoice, etc.) must tie back to each other with same vehicle, mileage, with an Operator/repair signature
- Vehicle inspection wheelchair tie-downs left in bus floor, not opening emergency exits regularly, no belt cutters, no Title VI information

## TRIANNUAL COMPLIANCE REVIEW GOOD PRACTICES

- Uploaded all Drug and Alcohol certificates and renewals in the agencies BlackCat resource file.
- Uses excel log to chronologically record Preventative
   Maintenance. The log lists: date, the last four numbers of the vehicle VIN number, mileage, lists the repair, and signature
- Keeps binder containing chronologically filed original documents by vehicle.
- Has Preventative Maintenance computer program.

- Drug Oral Swabs Delay in using oral swabs is due to not having two separate review labs. Oral swabs can not be used to collect drugs at this time.
- Annual on-line Safety Sensitive Operators training (60 mins on the effects and consequence of prohibited drug use on personal health, safety, and work environment, and the signs and symptoms that may indicate drug use)
- Suggested tri-annual on-line refresher Reasonable Suspicion for Managers training - 60 mins for Alcohol, and 60 mins for Drug - on the physical, behavioral, speech, and performance indicators of probable alcohol misuse and or probable drug use.
