


### 2025 Montana Aviation Educators Workshop Reaches New Heights

In early October, educators from across Montana gathered for the annual Aviation Educators Workshop, hosted by the Montana Department of Transportation (MDT) Aeronautics Division in partnership with the Montana Learning Center (MLC). This two-day event focused on connecting aviation with STEM (Science, Technology, Engineering, and Mathematics) education in engaging and innovative ways.

Participants enjoyed a variety of enriching activities, including classroom lessons on aviation science, hands-on experiments, and exclusive tours of aviation facilities at Helena Airport. A highlight was the opportunity for attendees to experience a flight aboard an MDT Aeronautics Division aircraft, providing real-world perspective on aviation

careers and training.



Open to Montana educators focused on STEM, this annual workshop offers 20 professional renewal units through the Montana Office of Public Instruction (OPI). By blending aviation and

STEM, the event plays a vital role in motivating the next generation of pilots and aerospace professionals throughout the state.

#### Winter Survival Clinic Jan 9-11

The MDT Aeronautics Division's Winter Survival Clinic provides pilots with critical skills to survive emergency landings in harsh winter conditions. Held at the Sugarloaf Lodge near Anaconda, the clinic offers hands-on training in shelter building, fire starting, signaling, and first aid. Participants also experience overnight survival exercises under expert guidance. This clinic honors pilot Terry Surratt's legacy by emphasizing preparedness in Montana's challenging terrain. The division develops programs like this to prepare pilots for emergency situations, strengthen aviation knowledge, and enhance survival readiness across Montana's aviation community. #### Search and Rescue Trains in Frigid Waters

Earlier this year, Lewis and Clark County Search and Rescue conducted a unique training initiative in partnership with the MDT Aeronautics Division. The team borrowed a decommissioned aircraft from MDT Aeronautics, which is used as a survival training aid. In a creative approach to emergency preparedness, the aircraft was sunk in Canyon Ferry Reservoir to serve as the centerpiece for scenario-based exercises.

Search and Rescue personnel conducted intensive aircraft-specific rescue and recovery drills using the submerged fuselage. The program provided volunteers the opportunity to practice emergency egress, water rescue, and aircraft recovery operations in conditions modeled after real aviation accidents. By using an actual decommissioned airplane and the challenging environment of Canyon Ferry, the training brought a new level of realism and skill development to these rescuers.



#### 2026 Flight Instructor Refresher Clinic

\*You do not have to be a flight instructor to attend\*

The Montana Aeronautics Flight Instructor Refresher Clinic (FIRC) is an annual FAA-approved course designed to help certified flight instructors (CFIs) renew their instructor certificates and stay current with the latest in aviation training and safety practices.

The 2026 clinic will be in Helena at the Doubletree Hotel February 6 - 7, 2026, from 8 a.m. to 5:30 p.m. both days.

#### Course Highlights

- Fulfills FAA renewal requirements for CFIs and Chief CFIs.
- Open not only to current and aspiring CFIs, but also to any pilots interested in professional development and aviation safety.
- The curriculum covers regulatory updates, safety topics, instructional techniques, and practical teaching strategies relevant to modern flight training.
- Attendees receive renewal credit upon successful completion, which supports the continued privilege to instruct under FAA
  regulations.

#### **Registration and Tuition**

- Tuition is \$75, with a \$25 discount for pilots registered in Montana.
- Montana pilot registration is available for \$10 per year, providing tuition savings and supporting state aviation programs.
- Registration is on a first-come, first-served basis, and non-instructors and students are encouraged.

The clinic is part of the MDT Aeronautics Division's broader efforts to promote flight safety and education throughout the state. This event provides important professional networking as well as opportunities to refresh teaching knowledge and learn about changes ingeneral aviation instruction and regulations. The Montana FIRC continues to serve as an essential resource for aviation professionals across the state, supporting the highest standards of flight instruction and safety.

Aircraft customarily kept in Montana, as well as any aircraft with a Montana address on its FAA registration, must be registered with the MDT Aeronautics Division on or before March 1st every year (or within 30 days of purchase date for any aircraft purchased).

Montana does not tax aircraft but instead issues an annual aircraft registration fee in lieu of tax. The fees are set by the Montana Legislature and are determined according to the type of aircraft and its age.

Annual renewal invoices will be mailed in the last week of November. Please be sure to check your mail.

- \* A statutory penalty for late registrations must be assessed in the amount of five times the registration fee if payment OR signed affidavit for exemption with supporting documentation is not received by the deadline.
- \* Please keep in mind that aircraft out of annual inspection are not considered "unairworthy" by administrative rule and will be subject to annual registration fees.

ACTION IS REQUIRED ON ALL AIRCRAFT REGISTRATIONS ANUALLY.

#### Did You Sell Your Airplane? Send Us Your Bill of Sale.

In order to cancel your state aircraft registration, the MDT Aeronautics Division requires a copy of the **FAA Bill of Sale**, per administrative rule 18.12.315(d), and must accompany your signed exemption affidavit found on the bottom portion of your annual renewal invoice.

The MDT Aeronautics Division must receive these documents by the annual renewal deadline of March 1st.

Aircraft owners who fail to provide all necessary paperwork before the deadline will be issued late fees and/or registration penalties.

Failure to provide the required proof for fee exemption is the leading cause of aircraft registration delinquency in Montana.


