Tailwinds - Gary Wolterman

It is with deep sorrow that we announce the passing of Gary George Woltermann of Columbus, Montana, who was lifted by a tailwind just after midnight on June 16, 2025, at the age of 84.


Flying became his love. He earned his private license at age 17, Commercial License at 18, and Flight Instructor at 21. At age 24, he was chosen to be a Designated Pilot Examiner by the FAA. For 40 years, he gave thousands of flight tests to aspiring student pilots that cemented life-long friendships in the aviation community. He had over 31,000 hours of flight time and held an Airline Transport Pilot (ATP) Certificate, rated in Multi-Engine and Single Engine Land, Single Engine Sea, Flight Instructor and type rated in a Douglas DC-B26 (WWII Bomber) and Cessna Citation Jets. His cherished baby was a Beechcraft Bonanza that he bought in 1964 and owned for nearly 60 years.

The Wright Brothers "Master Pilot" Award was presented to Gary on October 28, 2015, "In recognition of your contributions to building and

maintaining the safest aviation system in the world, through practicing and promoting safe aircraft flight operations for 50 consecutive years." He was an invited member of Ye Anciente and Secret Order of Quiet Birdmen and was a Certified Goodfellow - QB No. 22,998.

Aeronautics Loan & Grant Applications Open

As a reminder to airport loan and grant applicants, the loan and grant online portal will accept FY 2026 applications starting July 1, through November 15. If you cannot enter the website, you may have a previous award that needs a closeout form, or an annual status report filed.

Projects must be broken down by type and itemized on the application. For example, asphalt projects should be broken down by runway, apron, and taxiway, not as one project lumped together. Eligible projects may include airport pavements, safety related items, lighting, weather cameras, Weather reporting systems, fuel farms, and more.



FAA Announces MOSAIC

The Modernization of Special Airworthiness Certification (MOSAIC) final rule made revolutionary changes to the Light Sport Aircraft (LSA) category and to Sport Pilot privileges, expanding a safe alternative to experimental amateur-built aircraft by:

- Removing the 1,320-weight limit, which allows for more safety features and safety-design flexibility.
- Encompassing aircraft with higher speeds, more seats and retractable landing gear.
- Allowing for new types of propulsion and modern avionics.
- Allowing aerial work with LSA such as infrastructure and forest inspections, photography/filming, and agricultural surveillance.
- Allowing pilots operating under Sport Pilot privileges to fly a broader range of aircraft.
- Reducing regulatory requirements by expanding the types of aircraft that qualify as LSA and the types of aircraft pilots can fly
 under Sport Pilot privileges.
- Enables the manufacture and use of safe and economical aircraft for recreation and flight training.

Under MOSAIC, a sport pilot can fly most aircraft that have a stall speed up to 59 knots. Pilots holding a private pilot certificate or above can fly most aircraft that have a stall speed up to 61 knots.

This change means as much as 70% of the current general aviation fleet — including legacy airplanes such as the Cessna 172 — will be able to be flown by sport pilots. Allowing for new types of propulsion and modern avionics.

Limestone Hills Restricted Airspace Update

Restricted area R-4601 in the vicinity of Townsend, Montana was approved. The new restricted area will provide the Montana Army National Guard and the 40th Helicopter Squadron with the ability to conduct live-fire aerial gunnery training in the Limestone Hills Training Area. R-4601 extends from the surface to 9,000 feet and is located approximately four miles west of the Townsend Airport and extends approximately eight miles to the southwest.

It will be activated by a Notice to Airmen (NOTAM) to inform nonparticipants when the restricted area is active. When this airspace is not needed by the using agency for its designated purpose, the airspace will be returned to the controlling agency for access by other users. The controlling agency for this restricted area is the Salt Lake Center.

The use of R–4601 is restricted to 140 days of the year and the maximum estimated usage is up to 50 events that may occur during the day or night. During each usage, R–4601 would typically be used for a 2 to 3-hour block for a maximum total of 150 hours per year.

MDT Aeronautics Search and Rescue Services Activated

Around mid-July, a Piper Cherokee from Utah went missing in Montana around midnight. Almost 11 hours later the following day, concerned family members from another state reported they could not contact any of the three people believed to be on board the airplane. This triggered a search and rescue response led by the MDT Aeronautics Division (MDT Aeronautics is the responsible agency in charge of all civil aviation related to search and rescue in Montana).

The pilot did not file a flight plan and was not using flight following.

The aircraft's emergency locator transmitter was damaged in the accident; therefore, it was not working properly.

With little information to work from, MDT Aeronautics staff immediately began forensic cell phone, smart watch, and aircraft radar analysis to attempt to identify a last known location. With a soft location quickly identified, a volunteer search aircraft and observer were dispatched from Bozeman followed by the MDT Aeronautics primary search aircraft from Helena. The search aircraft swiftly located the wreckage and then county sheriffs' office ground and air rescue teams were mobilized to the location.

Tragically, there were no survivors.


