Blue Skies and Tailwinds, Roger

Roger Donald Lincoln passed away peacefully on July 22, 2026, in Kalispell, Montana, at the age of 87. Born on April 26, 1939, in Havre, Montana, Roger was the cherished son of Donald Lincoln and Mary (Ritter) Lincoln. He was raised in the tight-knit farming community of the Rudyard area along Montana's Hi-Line, where he developed a lifelong appreciation for the land, hard work, and the open skies of Big Sky Country.

On September 18, 1960, Roger married the love of his life, Mable Colbry. After a brief tour in the army, Roger and Mable returned to the farm. Together they built a life deeply rooted in love, family, and a shared commitment to God and their community, celebrating 65 wonderful years of marriage.

A member of a multi-generational flying legacy on the prairie, Roger took to the skies at an early age. A passion sparked when his parents gave him a flight for his birthday. He soloed on his sixteenth birthday in 1955, went on to earn his commercial pilot certificate, and built an impressive, decades-long career as a crop-spraying aviator across northern Montana. Flying over rolling fields of wheat was not just his work, but a calling he loved deeply and passed along to future generations. In 1975 Roger was honored with the U. S. Jaycees Outstanding Young Farmer Award. In 2020 Roger was honored with the Wright Brothers Master Pilot award, the highest honor the Federal Aviation Administration bestows on civilian pilots. Roger served on the Montana State Aeronautical Commission, First Bank Board of Directors, Hill County Farm Service Agency Committee, Havre Airport Board, Hi-Line Health Foundation Board, and multiple years as Chairman of the Board at Calvary Evangelical Church, among many other volunteer positions.

Above all, Roger cherished his family, his lifelong friends across Hill and Liberty counties, and the strong ties built throughout the Montana agricultural and aviation communities. His legacy lives on through his sons, grand children, family, and friends whose life has been blessed with his kind, wise words, and witty humor.

Overdue Flight Plans and ELT Alerts:

What Happens Behind the Scenes

MDT Aeronautics Search and Rescue (SAR) are responsible for all civilian aviation related SAR operations in Montana. They respond to approximately 30 calls a year. Most of those calls are regarding overdue aircraft that did not close their flight plans and/or accidental Emergency Locator Transmitter (ELT) activations.

Did you ever wonder what happens behind the scenes when these activations happen? If you don't close your flight plan and it becomes overdue, your ELT is set off accidentally, or there is an emergency. Here's what the process looks like:

1. When a flight plan becomes overdue, Flight Service initiates an investigation 30 minutes after the Estimated Time of Arrival. This marks the beginning of the Search and Rescue (SAR) process.
2. Within minutes of an ELT activation, the Air Force Rescue Coordination Center (AFRCC) receives notification, a 406MHz signal is detected. A 121.5MHz ELT signal, however, may take much longer—sometimes days—because it must first be detected by another aircraft and reported to Aircraft Control before it can be reported to the AFRCC.
3. The AFRCC then contacts MDT Aeronautics to report either an overdue aircraft or an ELT activation. The MDT Aeronautics SAR staff begins investigating to determine the aircraft's location or the source of the ELT signal.

SAR staff use all available information; Montana Pilot and Aircraft registration information, radar data, last known coordinates, intended destination, and other details from the flight plan. SAR personnel do not know whether the alert is accidental or a true emergency, so it is treated as an emergency until proven otherwise.

SAR staff rely on accurate flight plans and registration information to contact the individual/s associated with the aircraft and continue their search.

How Can You Help?

Flight Plans:

- Keep your contact information updated through your aircraft and Pilot registrations in MDT Aeronautics's system. MDT SAR need to be able to contact you quickly to resolve the incident or launch a search. To update your information give us a call at **406-444-2506**, email us at mdtad@mt.gov, or go online at app.mt.gov/aeronautics/registration/Contact/Lookup and use your access code to update your profile.
- File and activate a flight plan and *be sure to close it* when you get to your destination. Make clear flight plan updates and timely amendments. When filling your flight plan it is helpful to include contact information of who is traveling with you. Leaving a trail of information will help SAR find you faster in an emergency.

ELT's:

- Keep your ELT registration information up to date. If you acquire a new aircraft equipped with a 406MHz ELT, change your tail number or install a new ELT, you will need to update the registration information with the National Oceanic and Atmospheric Association at beaconregistration.noaa.gov/RGDB/index.
**The FAA does not update ELT registrations.*
- 406MHz: If you accidentally set off your ELT, call the **AFRCC** and let them know. They can be reached 24/7 at **1-800-851-3051**. Even if a 406MHz is on for a few seconds in your aircraft or inside a building, the AFRCC will notify MDT Aeronautics SAR to begin looking for you!
- 121.5MHz: Check your radio frequency 121.5MHz before shutting down your engine. Should your ELT accidentally be activated, you will hear it sounding.

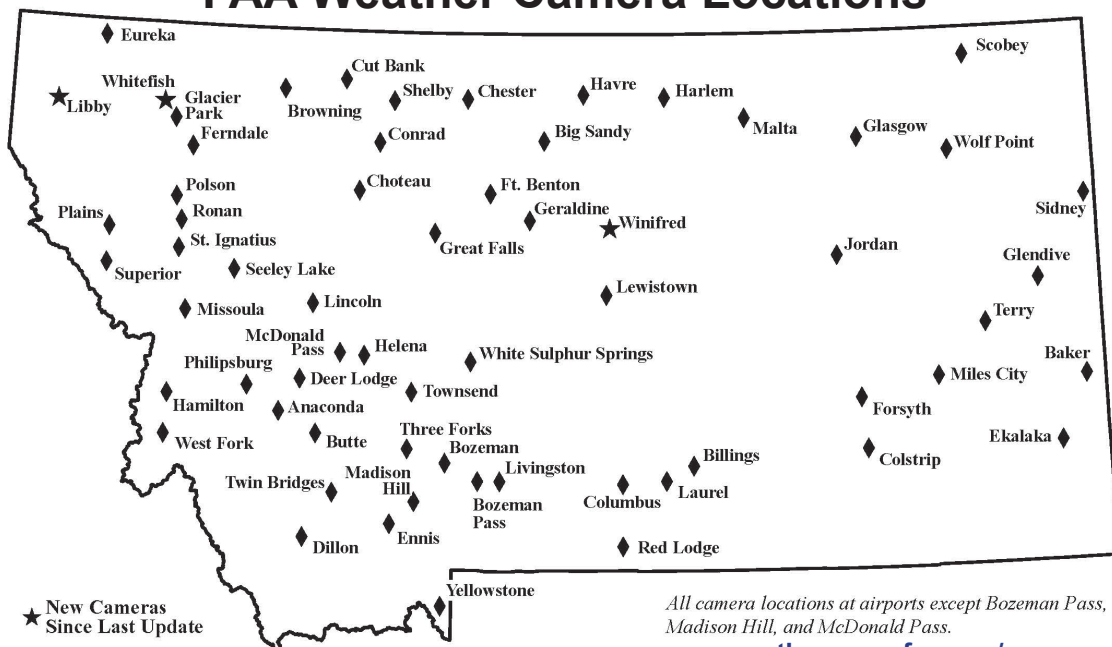
