Montana DUI Citation Data compiled from MHP & Board of Crime Control can also be found on the same page. It has been updated to include 2017 and provides a snapshot of DUI trends as a given time. Data can be queried by month, county and law enforcement agency. – *Completed*.

2018 looks to be similar as past years. So far January has seen an increase of cocaine in toxicology reports. An emerging concern showing up in toxicology testing is the substance of Kratom. Kratom is a natural substance and it is not illegal, which us why it is so available.

Strategy 3: Prevention Education

Christine Steele, AMDD Prevention Program (DPHHS) shared handout materials and reported on the Parenting Montana Campaign https://parentingmontana.org/ provides a comprehensive, evidence-based resources tools for children and parents to help develop skills for success. The goal is to cultivate a positive, healthy culture among Montana families with an emphasis on curbing underage drinking and provide resource tools to address everyday challenges. Age appropriate tools include anger, bullying, discipline, friends, peer pressure, conflict, chores, listening, homework, routines, back talk, lying, reading, stress, establishing rules and mixed messages about alcohol. Resources were developed through a partnership with DPHHS Addictive and Mental Disorders Division and MSU-WTI Center for Health & Safety Culture https://chsculture.org/ - Completed.

Teen Peer to Peer Safety program was shared by Sheila Cozzie, Cultural Liaison (MDT). Grant recipients have been notified. She will report out at the next meeting on grant awards. -In progress.
