#### **Old Business**

Montana Impaired Driving Assessment and State's Response

Data Update

- MDT will work with Board of Crime Control to update citation data.
- Elizabeth Smalley and Michelle Duffus provided a brief on the annual toxicology statistics for 2019. The annual report will be coming on in the next couple of months.

# Strategy #1: Support stronger impaired driving laws that increase penalties &/or arrest rates. Including those focusing on repeat offenders.

- Chad Parker provided a training update and information on legislative perspective proposed concepts regarding DUI legislation.

- Judge Knisley gave a brief on treatment court rollout and general court processes amongst the current COVID 19 situation.

## Strategy #2: Reduce impaired driving through enforcement.

 Chad Newman and Sergeant Doug Samuelson provided an update on law enforcement activities. The May Mobilization is now going to happen in November. Prepping for July 4<sup>th</sup> law enforcement efforts. Training law enforcement continues.

## Strategy #3: Reduce impaired road users through prevention education.

- Janet Kenny provided a brief on state highway traffic safety media efforts. Of specific discussion was the idea of media targeted to those that sell alcohol. Media concepts will continue to be discussed in the coming months.
- Shelia Cozzie provided a brief on Teen and Tribal Programs as well as Motorcycle Safety

#### Strategy #4: Continue to support and build collaborative partnerships to reduce impaired driving.

- Kevin Dusko provided an update on collaborative efforts. Elizabeth Smalley from the Forensic Crime Lab
  provided an update on installation of the new intoxilizers statewide. The intoxilizer 9000 is being
  purchased for jurisdictions statewide and the technology is being fine-tuned.
- 24/7 Program is undergoing some adjustments in administrative rules to allow for additional alcohol monitoring technology.

#### **New Business**

State Judicial Outreach Liaison

- Judge Knisley described the new State Judicial Outreach Liaison (SJOL) Project in collaboration with the American Bar Association. MDT applied for the position through the grant opportunity. The new SJOL will be implemented in the next couple of months. A position announcement will be posted soon.
- Janet Kenny provided latest on the NHTSA Funding and Highway Safety Plan Processes. Projects funded by NHTSA will be presented to Director Tooley in June.
- Pam gave a Comprehensive Highway Safety Plan Update. The CHSP Advisory Group will be meeting on May 14<sup>th</sup> to discuss strategies and targets.
