




Crime Lab Toxicology Report- Beth Smalley

Impaired Driving Strategic Plan

Provided an update to the Impaired Driving EA work plan, which serves as Montana Impaired Driving Strategic Plan. New additions are landing sections that describes the Executive Leadership Team (ELT)'s authority, role of ELT, members, process of plan development and placeholder for ELT approval date.

Strategy 1: Deterrence and Enforcement

DRE class funded w/ NHTSA just wrapped up. Second DRE school planned . Basic SFST Training is under way. May ARIDE scheduled

Law Enforcement Liaison (LEL) and is active in recruiting and retaining STEP programs and law enforcement entities to participate in mini-grant programs.

Helena Police Department is still activity in employing a full time traffic officer and will be providing a 50 % match during the next federal fiscal year.

STEP and SETT Programs are continuing to participate in mobilization periods and operating well. Mini Grants are provided to smaller jurisdictions for high visibility during special events. Law Enforcement Planner position is closed, and applicants are being screened.

Northern Tribes DUI Task Force working on developing next campaign. Next Northern Tribes DUITF meeting is on April 14th in Billings, MT.

Injury Prevention will be having some planning meetings in the coming months and will have additional updates at the June meeting.

RASS- Kent Haub released new version of curriculum with assistance of Steve Schmidt Partners include Wal-Mart, Town Pump, etc. Compliance checks are looking good. Under 6% fail rate. Focus on underage and overserviced

Strategy 3: Criminal Justice System

S3.1 Support stronger impaired driving laws.

Oral fluid testing for roadside testing approved by Legislature for new testing method but not included in reorganization and not tied to implied consent.

24/7 testing sites for either 2x daily testing and/or remote testing is active in 39 counties statewide.

There is a new Traffic Safety Resource Prosecutor (TSRP) that started recently. The position is housed within the Prosecution Services Bureau of the Attorney Generals Office.

Motor Carrier alcohol/ drug citations & out of service drivers

DUI Court Best Practices Training scheduled for Billings in the fall and will include Fort Peck and Gallatin County from Montana.

Strategy 4: Communication Program

National Mobilizations with the next one being the Memorial Day mobilization, which is a National Seatbelt Enforcement mobilization. SETT and STEP programs will be actively participating in with media firm.

Working on personal stories/impact. What's your reason campaign.

S4.3 Monitor the impact of marijuana legalization on roadway crashes and countermeasures in Montana and peer states. Great presentation from the Forensic Science Laboratory. New Highway Bill includes language encouraging States that have legalized adult use marijuana to develop a public educational campaign.

Strategy 5: Alcohol and Other Drug Misuse: Screening, Assessment, Treatment and Rehabilitation

A meeting with the Montana Health Care Foundation is scheduled to discuss Screening and Brief Intervention and referral to treatment.

Strategy 6: Program Evaluation and Data

S6.1 Support a comprehensive picture of impaired driving data, which may include, but is not limited to: Crash, Citation, Toxicology, Conviction, Motor Vehicle and DUI Offender monitoring data.
